Pre Bid Meeting: All interested bidders must attend the mandatory pre bid meeting on Monday, January 30, 2023 at 11:00 A.M. at the Schaumburg Township District Library Rasmussen North Room, 2<sup>nd</sup> Floor 130 S. Roselle Road, Schaumburg, IL 60193, unless prior arrangements have been made with the construction manager. Immediately following the pre bid meeting, interested bidders are invited to walk through the project site. A 5% bid bond is required. A public bid opening will be held at the Schaumburg Township District Library Rasmussen Room South, 2<sup>nd</sup> Floor 130 S. Roselle Road, Schaumburg, IL 60193 at 11:00 A.M. on Monday, February 13, 2023.

The Schaumburg Township District Library hereby notifies all bidders that it will affirmatively insure, that in any contract entered into pursuant to this advertisement, minority business enterprises will be afforded full opportunity to submit bids in response to this invitation and will not be discriminated against on the grounds of race, color, or national origin in consideration for an award.

Contractor agrees to be bound to the terms of its bid for a period of Sixty (60) calendar days after the Bid Opening Date.

The Schaumburg Township District Library reserves the right to award contracts to the lowest responsible bidder, to reject any and all bids, and to waive any irregularities in bidding. Bids received after the due date and time will be rejected.

If contracts are awarded, the successful bidder will be required to post performance, labor, and material payment bonds. In addition, the successful bidder will be required to comply with all applicable laws, including, as mentioned above the Prevailing Wage Act as well as the Illinois Human Rights Act. The successful bidder will execute contracts directly with Schaumburg Township District Library.
